BE IT RESOLVED, by the Council of The City of San Diego, that the City Manager be and he is hereby authorized and empowered to execute, for and on behalf of said City, a Utilities Agreement No. 25269 with THE STATE DEPARTMENT OF TRANSPORTATION, for the relocation of water facilities as part of the highway project Route 52 from 0.7 mile west of Route 805 to Convoy Street, under the terms and conditions set forth in the Utilities Agreement on file in the office of the City Clerk as Document No.

BE IT FURTHER RESOLVED, that the City Manager be and he is hereby authorized the use of City Forces to perform water main connection work and engineering design, the cost of which is estimated to be \$25,500.

BE IT FURTHER RESOLVED, that the expenditure of an amount not to exceed \$6,331.25 from CIP No. 73-024.0, Annual Allocation - Freeway Allocation is hereby authorized, solely and exclusively for the purpose of providing funds for the above project.
