authorization of a multi-site Foreign Trade Zone, with Brown
Field and the 24th Street Terminal as locations; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, that the City Manager is hereby authorized to proceed with selection of a consultant to prepare and present an application to the Foreign Trade Zone Board, Department of Commerce, for authorization of a Foreign Trade Zone.

BE IT FURTHER RESOLVED, that a General Fund Unallocated Reserve encumbrance of \$15,000 is hereby authorized to provide funding for these consultant services.
