WHEREAS, it has been determined by the City Council that legislative representation efforts in Sacramento be conducted by consultant contract in response to a competitive RFP process in lieu of the nonexclusive arrangement previously used; and

WHEREAS, after review of proposals submitted by interested parties in response to an extensive RFP process, it was decided to award the consultant contract to "APPLIED STRATEGIES", a joint venture between Richard E. Ratcliff, Inc., and John Witzel Associates, Incorporated; and

WHEREAS, such action will enable the City to have the expertise of two consultants in Sacramento for the eighteen-month contract period of January 1, 1986 through June 30, 1987; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, that the City Manager be and he is hereby fully authorized and empowered to execute, for and on behalf of said City, a Personal Services Agreement with APPLIED STRATEGIES, a joint venture between Richard E. Ratcliff, Inc., and John Witzel Associates, Inc., for the purpose of providing legislative representation services for The City of San Diego in Sacramento, California, for the period January 1, 1986 through June 30, 1987, pursuant to the

terms and conditions of the Personal Services Agreement on file  
in the office of the City Clerk as Document No. RR- 264714 .
