WHEREAS, The City of San Diego and the County of San Diego have jointly established the San Diego Energy Recovery (SANDER) Authority for the purpose of acquiring and maintaining a waste to energy facility pursuant to a Joint Exercise of Powers Agreement authorized by Resolution No. R-255161 of October 6, 1981; and

WHEREAS, the term of the San Diego Energy Recovery Authority will expire on January 1, 1986, by the terms of said Agreement, unless extended; and


WHEREAS, the City Council finds that continuation of the San Diego Energy Recovery Authority pursuant to the terms of the said Joint Exercise of Powers Agreement remains in the public interest; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, that this Council hereby agrees to extend the San Diego Energy Recovery (SANDER) Authority under the same terms and conditions originally set forth in the Joint Exercise of Powers Agreement creating such Authority for an additional six month term commencing on January 1, 1985, to expire July 1, 1986 with the concurrence of the County of San Diego, and therefore

authorizes the City Manager to execute a First Amendment to the  
Joint Exercise of Powers Agreement, in accordance with the  
document on file in the office of the City Clerk as Document No.
