RESOLUTION REQUESTING ESTABLISHMENT OF A SERVICE AUTHORITY FOR FREEWAY EMERGENCIES IN SAN DIEGO COUNTY.

WHEREAS, Division 3, Chapter 14 of the Streets and Highways Code was added by Chapter 1350 of the Statutes of 1985 providing for the establishment of a Service Authority for Freeway Emergencies (SAFE) if the Board of Supervisors of the County and a majority of the Cities within the County having a majority of the population adopt resolutions providing for the establishment of the authority; and

WHEREAS, the City Council finds that a freeway emergency motorist aid system is needed to protect the safety of motorists on freeways; and

WHEREAS, the City Council finds that a freeway emergency motorist aid system is needed to reduce the time spent by law enforcement officers responding to routine vehicle disablements; and

WHEREAS, SAFE will have responsibility for implementing a freeway emergency motorist aid system in the San Diego region; and

whereas, SAFE will have seven authority members, two of which are appointed by the San Diego County Board of Supervisors and the remaining five by the Cities within the County; and

WHEREAS, two thirds of all freeway mileage in the enclosed areas of the County of San Diego lie within the City limits of the City of San Diego; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, as follows:

- 1. That a Service Authority for Freeway Emergencies should be established in San Diego County pursuant to section 2550 of the Streets and Highways Code.
- 2. That the City Council finds it to be appropriate and equitable that three of the City members of SAFE be appointed by the Council of the City of San Diego.
