RESOLUTION NUMBER R-264733

ADOPTED ON DECEMBER 16, 1985

WHEREAS, the Citizens Advisory Board on Police/Community Relations was established by Ordinance No. O-16474 (New Series) on July 29, 1985; and

WHEREAS, the provisions governing said Advisory Board, including but not limited to appointments thereto, are contained in section 26.08 of the San Diego Municipal Code; and

WHEREAS, the membership of said Board is set forth in section 26.08 B., specifying a membership of thirteen people; and

WHEREAS, subsection B.2 requires three names be submitted in nomination by each Council District so that the Mayor may select one (1) therefrom; and

WHEREAS, subsection B.2 also authorizes the appointment of five (5) additional persons from various specified disciplines; and

WHEREAS, all members of the Board have been appointed except the member from District 7 because that seat has heretofore been vacant; and

WHEREAS, the Council seat is now occupied and wishes to have its nominee formally appointed to the Board; and

WHEREAS, it is now necessary that the name selected by the Presiding Officer be submitted to the full Council for confirmation; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, that the appointment by the Deputy Mayor of The City of San Diego of Norma McNerney to serve as a member of the Citizens Advisory Board on Police/Community Relations, to fill the vacancy of Council District 7, for a term to expire July 1, 1986, be and the same is hereby confirmed.
