Dolores Zapata	General Services	\$ 485.00	Ms. Zapata was an Equipment Technician I with the Communications & Electrical Division at the time of this suggestion. She suggested using a pneumatic tool drill and self tapping screws for radio installations and strippings. This is expected to save \$3,247.28 in time.
Catherine M. Jagers	Police	\$ 365.00	Ms. Jagers was an Intermediate Typist with the Traffic Division at the time of this suggestion. One year ago she suggested developing a coded filing system for material generated on a word processor. One year's experience has shown a savings of \$1,960.40. This is the remainder of her award.
Dennis L. Marnell	General Services	\$ 265.00	Mr. Marnell is a Mechanic in the Equipment Division. He suggested modifying the Striker Plate on the Crane Carriers. This is expected to save \$1,768.52 in time and materials.
Jonathan T. Harker	Building Inspection	\$ 185.00	Mr. Harker is a Building Technician II. He suggested designing a zoning correction sheet for the Mission Beach Planned District. His suggestion is expected to save \$1,221.74 in time.
