<u>NAME</u>	<u>DEPARTMENT</u>	<u>AMOUNT</u>	<u>SUGGESTION</u>
Norval L. Brewer	Fire	\$ 105.00	Mr. Brewer is a Battalion Chief. He suggested providing quick coupling and the necessary wiring on all fire apparatus, so Opticom heads will be interchangeable. One year's experience has shown a savings of \$8,277.28.
David L. Gerber	General Services	\$ 50.00	Mr. Gerber is a Refrigeration Mechanic with the Buildings Division. He suggested using protective film for the stick-on labels used on the Handie-Talkies. Although savings were difficult to identify, this was considered to be a significant operational improvement.
Craig Tennesen	Engineering & Development	\$ 25.00	Mr. Tennesen is an Associate Traffic Engineer. He suggested an improved procedure for telephone answering at Streets Division-Rose Canyon. Although savings were difficult to identify, this was considered to be a significant operational improvement.
John F. Flynn	Police	\$ 5.00	Mr. Flynn was a Police Officer II with the Vice Unit at the time of this suggestion. One year ago he suggested eliminating xeroxing of arrest reports for the Vice-Squad. One year's experience has shown a savings of \$1,418.92. This is the remainder of his award.
