

RESOLUTION NUMBER R- 264741

ADOPTED ON DEC 17 1985

A RESOLUTION AMENDING THE PROGRESS GUIDE AND GENERAL PLAN FOR THE CITY OF SAN DIEGO TO REFLECT THEREIN THE MISSION VALLEY COMMUNITY PLAN, 1962 EAST MISSION VALLEY AREA PLAN (RESCINDED), 1968 REVISED EAST MISSION VALLEY AREA PLAN (RESCINDED), SERRA MESA COMMUNITY PLAN, LINDA VISTA COMMUNITY PLAN, UNIVERSITY COMMUNITY PLAN, MIRA MESA COMMUNITY PLAN, MISSION TRAILS REGIONAL PARK MASTER DEVELOPMENT PLAN, TIERRASANTA COMMUNITY PLAN, EAST ELLIOTT COMMUNITY PLAN, AND VALLEY ROAD REORGANIZATION.

WHEREAS, California Government Code Sections 65350 through 65361 require that amendments to the PROGRESS GUIDE AND GENERAL PLAN FOR THE CITY OF SAN DIEGO shall require successive affirmative votes by both the Planning Commission and Council of The City of San Diego, but limits amendments to mandatory elements of the General Plan to four per year; and

WHEREAS, Council Policy 600-7 establishes procedures for amending the General Plan, including the stipulation that possible amendments shall be accumulated and periodically scheduled for combined public hearings and Council action, so as not to exceed the limits imposed by Section 65361; and

WHEREAS, within the period April 1, 1985 to October 1, 1985, the Council of The City of San Diego has approved the following:

1. Mission Valley Community Plan, adopted June 25, 1985 by Resolution No. 263536, associated EIR-84-0194 certified by Resolution No. 263535;

2. 1962 East Mission Valley Area Plan, rescinded June 25, 1985 by Resolution No. 263536, associated EIR-84-0194 certified by Resolution No. 263535;
3. 1968 Revised East Mission Valley Area Plan, rescinded June 25, 1985 by Resolution No. 263536, associated EIR-84-0194 certified by Council Resolution No. 263535;
4. Serra Mesa Community Plan, amended June 25, 1985 by Resolution No. 263537, associated EIR-84-0194 certified by Resolution No. 263535;
5. Linda Vista Community Plan, amended June 25, 1985 by Resolution No. 263538, associated EIR-84-0194 certified by Resolution No. 263535;.
6. University Community Plan, amended August 20, 1985 by Resolution No. 263940, associated END-84-0878 certified By Resolution No. 263939;
7. Mira Mesa Community Plan, amended August 20, 1985 by Resolution No. 263936, associated EMND-82-0237 certified by Resolution No. 263934, and EMND-84-0777 certified by Resolution No. 263935;
8. Mission Trails Regional Park Master Development Plan, adopted April 29, 1985 by Resolution No. 263065, associated EIR-84-0811 (an addendum to EIR-78-08-15) certified by Resolution No. 263064;
9. Tierrasanta Community Plan, amended April 29, 1985 by Resolution No. 263065, associated EIR-84-0811 (an addendum to EIR-78-08-15) certified by Resolution No. 263064;
10. East Elliott Community Plan, amended April 29, 1985 by Resolution No. 263065, associated EIR-84-0811 (an addendum to EIR-78-08-15) certified by Resolution No. 263064;
11. Valley Road Reorganization, annexation and zoning effective August 1, 1985. The City of National City was the conducting authority for the annexation proceedings. The San Diego City Council approved the rezoning on June 10, 1985 by Ordinance No. O-16444 (New Series); exempt from CEQA; and

WHEREAS, the Planning Commission and the Council of The City of San Diego conducted public hearings on November 21, 1985 and December 17, 1985, respectively, to consider amending the GENERAL PLAN MAP to reflect those plans and annexations approved by the City Council between April 1, 1985 and October 1, 1985; and

WHEREAS, said proposed amendment to the PROGRESS GUIDE AND GENERAL PLAN FOR THE CITY OF SAN DIEGO will not become effective until approved by the Planning Commission and adopted by the Council; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, that said amendments to the GENERAL PLAN MAP of the PROGRESS GUIDE AND GENERAL PLAN FOR THE CITY OF SAN DIEGO be, and the same are hereby adopted.
