Such additions therein and changes thereto as may be deemed necessary or advisable by the City Manager may be made in

said form in connection with the execution thereof; such execution thereof to constitute conclusive evidence of the approval of the City Manager and of the City of all additional changes from said form.

BE IT FURTHER RESOLVED, that the City Manager (or his designee), on behalf of the City, is hereby authorized to execute the above-referenced Owner-Grantee Agreement.

BE IT FURTHER RESOLVED, that the City Manager (or his designee) is hereby authorized, on behalf of the City, to sign all documents necessary and appropriate to carry out and implement the terms of the Owner-Grantee Agreement and to administer the City's obligations, responsibilities and duties under the Owner-Grantee Agreement.
