A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF SAN DIEGO APPROVING THE COOPERATION AGREEMENT BETWEEN THE CITY AND THE REDEVELOPMENT AGENCY OF THE CITY OF SAN DIEGO.

WHEREAS, The City of San Diego (the "City") entered into United States Department of Housing and Urban Development Housing Development Grant Agreement No. CA013HG401 to receive funds in the amount of THREE MILLION SEVEN HUNDRED TWENTY THOUSAND ONE HUNDRED EIGHTY-SIX DOLLARS (\$3,720,186, the "HDG Grant") for the purpose of offsetting project development costs on the Market Street Square Apartment Project (the "Project") in the Marina Redevelopment Project Area (the "Project Area"); and

WHEREAS, the Redevelopment Agency of The City of San Diego (the "Agency") is engaged in activities necessary to carry out and implement the Redevelopment Plan for the Project Area; and

WHEREAS, the City desires to use the staff, skills and facilities of the Agency to implement the above-referenced Project; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, that the proposed Cooperation Agreement between the City and the Agency, substantially in the form on file in the office of the City Clerk as Document No. RR-264749, is hereby approved. Such additions therein and changes thereto as may be deemed necessary or advisable by the City Manager may be made in said


