WHEREAS, the Council entertained a proposal for establishing an Ad Hoc Special Committee for City School food and, in connection therewith, designating a Councilmember as Council liaison for an Ombudscience program; and


WHEREAS, the committee and program proposal was intended to be for a period of one (1) year so that the concept could be explored; and

WHEREAS, the Council discussed the matter and decided to act thereon; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, that pursuant to section 43(b) for the City Charter, there is hereby created an Ad Hoc Special Subcommittee for City School food planning program, said Ad Hoc Special Subcommittee to perform as appointed for one (1) year until an expiration date of November 17, 1986.

BE IT FURTHER RESOLVED, that Councilmember Bill Cleator be and he is hereby designated as Council liaison for the Ombudscience program, in conjunction with the above program, for a one (1) year period ending November 17, 1986.
