AN ORDINANCE AMENDING ORDINANCE NO. 0-16475 (NEW SERIES), AS AMENDED, ENTITLED "AN ORDINANCE ADOPTING THE ANNUAL BUDGET FOR THE FISCAL YEAR* 1985-86 AND APPROPRIATING THE NECESSARY MONEY TO OPERATE THE CITY OF SAN DIEGO FOR SAID FISCAL YEAR" BY AMENDING DOCUMENT NO. 00-16475-1, AS AMENDED AND ADOPTED THEREIN, BY TRANSFERRING THE SUM OF \$750,000 FROM THE SPECIAL LITIGATION LIABILITY RESERVE FUND (FD 65011) TO THE GENERAL FUND 100, CITY CLERK DEPARTMENT (035) FOR THE SOLE AND EXCLUSIVE PURPOSE OF PROVIDING FUNDS TO CONDUCT A SPECIAL ELECTION FOR THE OFFICE OF MAYOR; AUTHORIZING THE EXPENDITURE OF SAID FUNDS FOR THAT PURPOSE; EXPRESSING INTENT TO REIMBURSE SAID SPECIAL LITIGATION LIABILITY RESERVE FUND (FD 65011) WITH UNAPPROPRIATED REVENUE WHICH IS EXPECTED TO BE IDENTIFIED BEFORE THE ANNUAL 4TH QUARTER ADJUSTMENT TO THE ANNUAL APPROPRIATION ORDINANCE.

WHEREAS, the City Council expressed its intent to hold a special election for the office of the Mayor of The City of San Diego in February, 1986; and

WHEREAS, said special election in February constitutes a primary election, with a possible general election to be conducted in June in the event no candidate receives a majority of votes cast in February; and

WHEREAS, the cost of both elections is calculated to be \$750,000; and

whereas, the City Clerk's office did not and does not have, any funds budgeted for said special election and requires a transfer of funds to his budget for the sole and exclusive purpose of defraying expenses of said election; and

WHEREAS, funds are available for transfer with the proviso that the sum transferred be returned to the source when additional revenue is appropriated during the latter part of the fiscal year; NOW, THEREFORE,

BE IT ORDAINED, by the Council of The City of San Diego, as follows:

Section 1. That Ordinance No. O-16475 (New Series), as amended, entitled "AN ORDINANCE ADOPTING THE ANNUAL BUDGET FOR THE FISCAL YEAR 1985-86 AND APPROPRIATING THE NECESSARY MONEY TO OPERATE THE CITY OF SAN DIEGO FOR SAID FISCAL YEAR," be and the same is hereby amended by amending Document No. 00-16475-1, as amended and adopted therein by transferring the sum of \$750,000 from the Special Litigation Liability Reserve Fund (FD 65011) to the General Fund 100, City Clerk Department (035) for the sole and exclusive purpose of providing funds to conduct a special election for the office of mayor.

Section 2. That the Auditor and Comptroller be and he is hereby fully authorized to expend the funds for the purpose stated above, pursuant to the estimates set forth in the December 17, 1985 memorandum from the City Manager to the Acting Mayor and Council, Subject "Special Election Financing;" a copy of which is on file in the office of the City Clerk as Document No.

Section 3. That the Council hereby directs that the sum of \$750,000 authorized above for transfer be reimbursed to the Special Litigation Liability Reserve Fund (FD 65011) with Unappropriated Revenue which is expected to be identified before

the annual 4th quarter adjustment to the Annual Appropriation Ordinance.

Section 4. This ordinance shall take effect and be in force immediately upon its adoption after two (2) public hearings, pursuant to the authority contained in sections 16, 17 and 71 of the Charter of The City of San Diego.
