AN ORDINANCE AMENDING ORDINANCE NO. 0-16475 (NEW SERIES), AS AMENDED, ENTITLED "AN ORDINANCE ADOPTING THE ANNUAL BUDGET FOR THE FISCAL YEAR 1985-86 AND APPROPRIATING THE NECESSARY MONEY TO OPERATE THE CITY OF SAN DIEGO FOR SAID FISCAL YEAR" BY AMENDING DOCUMENTS NO. 00-16475-1 AND NO. 00-16475-2, AS AMENDED AND ADOPTED THEREIN, BY ADDING TO THE PERSONNEL AUTHORIZATION OF THE PLANNING DEPARTMENT (065), ONE (1.00) INTERMEDIATE TYPIST POSITION, ONE (1.00) ZONING REPRESENTATIVE, ONE (1.00) BUILDING INSPECTOR II POSITION; TRANSFERRING THE SUM OF \$51,851 WITHIN THE GENERAL FUND 100, FROM UNALLOCATED RESERVE (605) TO THE PLANNING DEPARTMENT (065) FOR THE PURPOSE OF FULLY FUNDING THE ABOVE AUTHORIZED POSITION AND RELATED NON-PERSONNEL EXPENDITURES FOR THE REMAINDER OF FISCAL YEAR 1986.

WHEREAS, on October 16, 1985, the Transportation and Land Use Committee reviewed staffing levels of the Sign Code
Administration Program; and

WHEREAS, such Committee consideration encompassed review and discussion of Planning Department Report No. 85-602 which recommended the action of three positions as specified herein; and

WHEREAS, said positions are to be hired during fiscal year 1986, to be funded from the Unallocated Reserve and, in succeeding years, to be regularly budgeted; and

WHEREAS, the Transportation and Land Use Committee approved said proposals on October 16, 1985 and recommended forwarding the matter to the full Council for appropriate action; and

WHEREAS, it is necessary to amend the annual appropriation ordinance to effectuate such addition to the Planning Department Budget; NOW, THEREFORE,

BE IT ORDAINED, by the Council of The City of San Diego, as follows:

Section 1. That Ordinance No. O-16475 (New Series), as amended, entitled "AN ORDINANCE ADOPTING THE ANNUAL BUDGET FOR THE FISCAL YEAR 1985-86 AND APPROPRIATING THE NECESSARY MONEY TO OPERATE THE CITY OF SAN DIEGO FOR SAID FISCAL YEAR," be and the same is hereby amended by amending Documents No. OO-16475-1 and No. OO-16475-2, as amended and adopted therein, by adding to the personnel authorization schedule of the Planning Department (065), One (1.00) Intermediate Typist position, one (1.00) Zoning Representative position and one (1.00) Building Inspector II position.

Section 2. That the Auditor and Comptroller be and he is hereby, authorized and directed to transfer within the General Fund 100, the sum of \$51, 851 from the Unallocated Reserve (605) to the Planning Department (065) for the purpose of fully funding the above authorized positions and related non-personnel expenses for the remainder of the fiscal year 1986.

Section 3. This ordinance shall take effect and be in force immediately upon its adoption after two (2) public hearings,

pursuant to the authority contained in sections 16, 17 and 71 of the Charter of The City of San Diego.
