ORDINANCE NUMBER O- 16577

JAN 21 1986

BE IT ORDAINED, by the Council of The City of San Diego, as follows:

Section 1. That those properties bounded approximately by I-805 and SR-15 on the West; I-8, Fairmount Avenue, Montezuma Road, Collwood Boulevard and El Cajon Boulevard on the North; the City of La Mesa on the East; and Highway 94 on the South, in the Mid-City Community Plan area, in the City of San Diego, California, within the boundary designated on Zone Map Drawing No. C-706.1, filed in the office of the City Clerk as Document No. **D-16576**, be, and the same is incorporated into the Mid-City Planned District and other zones as described and defined in the San Diego Municipal Code.

Section 2. That all prior ordinances of The City of San Diego are hereby repealed insofar as they conflict herewith.

Section 3. This ordinance shall take effect and be in force on the thirtieth day from and after its passage, and no building permits for development inconsistent with the provisions of this ordinance shall be issued unless application therefor was made

prior to the date of introduction of this ordinance or a final map for a Planned Residential Permit was approved by the City Council prior to the effective date of this ordinance.
