AN ORDINANCE AMENDING ORDINANCE NO. 0-16475 (NEW SERIES), AS AMENDED, ENTITLED "AN ORDINANCE ADOPTING THE ANNUAL BUDGET FOR THE FISCAL YEAR 1985-86 AND APPROPRIATING THE NECESSARY MONEY TO OPERATE THE CITY OF SAN DIEGO FOR SAID FISCAL YEAR" BY AMENDING DOCUMENTS NO. 00-16475-1 AND NO. 00-16475-2, AS AMENDED AND ADOPTED THEREIN, BY ADDING TO THE FY 1986 CAPITAL IMPROVEMENTS PROGRAM A NEW PROJECT, CIP NO. 37-417, ENTITLED "CITY OPERATIONS BUILDING - PERMIT CENTER CONSTRUCTION"; TRANSFERRING THE SUM OF \$2,300,000 FROM THE BUILDING INSPECTION DEPARTMENT ENTERPRISE FUND 41300, UNAPPROPRIATED FUND BALANCE, TO CIP NO. 37-417; ADDING TO THE PERSONNEL AUTHORIZATION OF THE BUILDING INSPECTION DEPARTMENT (130) TWELVE (12.00) NEW POSITIONS FOR SAID OPERATION; TRANSFERRING THE SUM OF \$195,257 FROM THE BUILDING INSPECTION DEPARTMENT ENTERPRISE FUND 41300, UNAPPROPRIATED FUND BALANCE, TO THE BUILDING INSPECTION DEPARTMENT (130) FOR THE PURPOSE OF FUNDING PERSONNEL COSTS OF THE ADDITIONAL POSITIONS AUTHORIZED: DIRECTING THE CITY MANAGER TO BRING BACK TO COUNCIL FOR ACTION, WITHIN SIXTY (60) DAYS, THE APPROPRIATE OFF-SITE LEASE AND CONSULTANT SERVICE AGREEMENTS REQUIRED TO IMPLEMENT THE CONSOLIDATED PERMIT PROCESSING CENTER.

WHEREAS, on October 28, 1985, the Rules Committee considered the City Manager's recommendations regarding the conversion of Plaza Hall to a Permit Center effective June 1987; and

WHEREAS, while the building industry supported the concept, concerns were expressed by Convis and others associated with the tourism industry regarding the timing of the proposal in relation to the scheduled opening of the Convention Center, as well as for the need to retain a facility for community events and small

trade shows until suitable alternative facilities are available, and .

WHEREAS, Council rejected the concept of converting Plaza Hall at this time, but directed the City Manager to pursue the alternative recommendation of establishing a Permit Center on the third and fourth floors of the City Operations Building as an interim measure; and

WHEREAS, the City Manager was directed to report back to the Rules Committee on November 25 with information regarding costs, funding sources and timing associated with implementing the alternative recommendation; and

WHEREAS, the City Manager provided the requested information in his Report No. 85-572, dated November 20, 1985, in which several recommendations were submitted concerning the conversion of the third and fourth floors of the City Operations Building into a consolidated Permit Center; and

WHEREAS, in said City Manager's Report No. 85-572, it was also recommended that twelve (12) additional positions be authorized in the Building Inspection Department to accommodate the requirements of the consolidated Permit Center; and

WHEREAS, said City Manager's report and the recommendations contained therein were considered by the Rules Committee on January 6, 1986 and approved by a 4-0 vote; and

WHEREAS, in order to effectuate the action recommended therein, it is necessary to amend the annual appropriation ordinance to so provide for the consolidated Permit Center and , add the necessary personnel; and

WHEREAS, the matter is forwarded to the full Council for appropriate action consistent with the above recitals; NOW, THEREFORE,

BE IT ORDAINED, by the Council of The City of San Diego, as follows:

Section 1. That Ordinance No. O-16475 (New Series), as amended, entitled "AN ORDINANCE ADOPTING THE ANNUAL BUDGET FOR THE FISCAL YEAR 1985-86 AND APPROPRIATING THE NECESSARY MONEY TO OPERATE THE CITY OF SAN DIEGO FOR SAID FISCAL YEAR," be and the same is hereby amended by amending Documents No. OO-16249-1 and No. OO-16249-2, as amended and adopted therein, by adding to the Fiscal Year 1986 Capital Improvements Program a new project, CIP No. 37-417, entitled "City Operations Building - Permit Center Construction."

Section 2. That the Auditor and Comptroller be and he is hereby authorized to transfer the sum of \$2,300,000 from the Building Inspection Department Enterprise Fund 41300, Unappropriated Fund Balance, to CIP No. 37-417 for the purpose of funding the above authorized CIP project.

Section 3. That the budget ordinance specified above in Section 1 be further amended to add to the personnel authorization of the Building Inspection Department (130) twelve (12) new positions to augment and staff the newly created consolidated Permit Center, said positions identified as follows:

- 1.0 Senior Planner
- 1.0 Associate Planner
- 11.0 Senior Zoning Representative
- 1.0 Zoning Representative
- 2.0 Assistance Civil Engineers
- 2.0 Assistant Structural Engineers
- 3.0 Building Inspection Technicians II
- 11.0 Total Positions
- *1.0 Implementation Manager

*Temporary position limited to term of implementation

Section 4. That the Auditor and Comptroller be and he is hereby further authorized to transfer the sum of \$195,257 from the Building Inspection Department Enterprise Fund 41300, Unappropriated Fund Balance, to the Building Inspection Department (130) for the sole and exclusive purpose of funding personnel costs of the additional personnel authorized in Section 3 above through the end of fiscal year 1986.

Section 5. That the City Manager be and he is hereby directed to bring back for Council action, within sixty 60) days, the appropriate off-site lease and consultant service agreements required to implement the consolidated service agreements required to implement the consolidated permit processing center.

Section 6. This ordinance shall take effect and be in force immediately upon its adoption after two (2) public hearings,

pursuant to the authority contained in sections 16, 17 and 71 of the Charter of The City of San Diego.
