

ORDINANCE NUMBER O- 16588 (NEW SERIES)

ADOPTED ON FEB 3 1986

AN ORDINANCE INCORPORATING THE EAST 1/2 OF LOT 3, SECTION 10, TOWNSHIP 15 SOUTH, RANGE 3 WEST, S.B.B.M. (A 15-ACRE SITE), LOCATED ON THE NORTH SIDE OF MIRAMAR ROAD BETWEEN MIRAMAR PLACE AND MIRAMAR MALL, IN THE UNIVERSITY COMMUNITY PLAN AREA, IN THE CITY OF SAN DIEGO, CALIFORNIA, INTO M-1B ZONE, AS DEFINED BY SECTION 101.0435.2 OF THE SAN DIEGO MUNICIPAL CODE, AND REPEALING ORDINANCE NO. 10936 (NEW SERIES), ADOPTED OCTOBER 5, 1972, OF THE ORDINANCES OF THE CITY OF SAN DIEGO INsofar AS THE SAME CONFLICTS HEREWITH.

BE IT ORDAINED, by the Council of The City of San Diego, as follows:

Section 1. That the east 1/2 of Lot 3, Section 10, Township 15 South, Range 3 West, S.B.B.M. (a 15-acre site), located on the north side of Miramar Road between Miramar Place and Miramar Mall, in the University Community Plan area, in the City of San Diego, California, within the boundary of the district designated "M-1B" on Zone Map Drawing No. B-3626, filed in the office of the City Clerk as Document No. 769276, be, and it is hereby incorporated into M-1B Zone, as such zone is described and defined by Section 101.0435.2 of the San Diego Municipal Code.

Section 2. That Ordinance No. 10936 (New Series), adopted October 5, 1972, of the ordinances of The City of San Diego, be and it is hereby repealed insofar as it conflicts herewith.

Section 3. This ordinance shall take effect and be in force on the thirtieth day from and after its passage, and no building

permits for development inconsistent with the provisions of this ordinance shall be issued unless application therefor was made prior to the date of adoption of this ordinance.
