AN ORDINANCE AMENDING SECTION 2 OF ORDINANCE NO. O-16456 (NEW SERIES), ADOPTED JULY 1, 1985, BY AMENDING THE CARMEL MOUNTAIN RANCH SPECIAL SIGN DISTRICT GUIDELINES.

WHEREAS, a request has been received to amend the provisions of the "Carmel Mountain Ranch Special Sign District Guidelines," a copy of which is on file in the office of the City Clerk As Document No. OO-16456-2; NOW, THEREFORE,

BE IT ORDAINED, by the Council of The City of San Diego, as follows:

Section 1. That Section 2 of Ordinance No. OO-16456 (New Series), adopted July 1, 1985, is hereby amended to read as follows:

Section 2. That the provisions of the "Carmel Mountain Ranch Special Sign District Guidelines," a copy of which is on file in the office of the City Clerk as Document No.

OO- 16597, shall apply to the approximately 1500 acres identified on Drawing No. C-686.

Section 2. This ordinance shall take effect and be in force on the thirtieth day from and after its passage, and no permits to erect and display signs in this community inconsistent with the provisions of this ordinance shall be issued unless

application therefor was made prior to the date of the adoption.
