AN ORDINANCE INCORPORATING A PORTION OF PUEBLO LOT 239, MISCELLANEOUS MAP 36 (A 1.49-ACRE SITE), A PORTION OF PUEBLO LOT 239, MISCELLANEOUS MAP 36 AND LOTS 37, 51 AND A PORTION OF LOT 49, WESTLAWN MAP 1464 (A 1.4-ACRE SITE), LOCATED ON THE NORTHEAST SIDE OF CAUBY STREET, BETWEEN GAINES STREET AND MIDWAY DRIVE, IN THE MIDWAY COMMUNITY PLAN AREA, IN THE CITY OF SAN DIEGO, CALIFORNIA, INTO CR AND C-1 ZONES, AS DEFINED BY SECTIONS 101.0421.1 AND 101.0430, RESPECTIVELY, OF THE SAN DIEGO MUNICIPAL CODE, AND REPEALING ORDINANCE NO. 34 (NEW SERIES), ADOPTED SEPTEMBER 12, 1932, AND ORDINANCE NO. 11210 (NEW SERIES), ADOPTED JANUARY 10, 1974, OF THE ORDINANCES OF THE CITY OF SAN DIEGO INSOFAR AS THE SAME CONFLICT HEREWITH.

BE IT ORDAINED, by the Council of The City of San Diego, as follows:

Section 1. That a portion of Pueblo Lot 239, Miscellaneous Map 36 (a 1.49-acre site), and a portion of Pueblo Lot 239, Miscellaneous Map 36, and Lots 37, 51 and a portion of Lot 49, Westlawn Map 1464 (a 1.4-acre site), located on the northeast side of Cauby Street, between Gaines Street and Midway Drive, in the Midway Community Plan area, in The City of San Diego, California, within the boundary of the district designated "CR" and "C-1" on Zone Map Drawing No. B-3676, filed in the office of the City Clerk as Document No. 769311, be, and it is hereby incorporated into CR and C-1 Zones, as such zones are described and defined by Sections 101.0421.1 and 101.0430, respectively, of the San Diego Municipal Code.

Section 2. That Ordinance No. 34 (New Series), adopted September 12, 1932, and Ordinance No. 11210 (New Series), adopted January 10, 1974, of the ordinances of The City of San Diego be and they are hereby repealed insofar as they conflict herewith.

Section 3. This ordinance shall take effect and be in force on the thirtieth day from and after its passage, and no building permits for development inconsistent with the provisions of this ordinance shall be issued unless application therefor was made prior to the date of adoption of this ordinance.
