ADOPTED ON MAR 31 1986

AN ORDINANCE OF THE CITY OF SAN DIEGO AMENDING ORDINANCE NUMBER O-16068, WHICH GRANTED TO COASTSIDE CABLE TELEVISION, INC. THE NON-EXCLUSIVE RIGHT, PRIVILEGE AND FRANCHISE TO LAY AND USE LINES, WIRES, COAXIAL CABLE AND APPURTENANCES FOR TRANSMITTING, DISTRIBUTING AND SUPPLYING RADIO AND CABLE TELEVISION SERVICE ALONG, ACROSS AND UPON THE PUBLIC STREETS, WAYS, ALLEYS AND PLACES WITHIN CERTAIN AREAS OF SAN DIEGO BY AMENDING SECTION 7(b) TO CHANGE THE COMMENCEMENT DATE FROM MARCH 22, 1982 TO NOVEMBER 23, 1983.

BE IT ORDAINED, by the Council of The City of San Diego, as follows:

Section 1. That Section 7(b) of Ordinance Number O-16068 is amended to read as follows:


(b) The term of this Franchise shall be sixty (60) months, commencing on the effective date of the Navy Contract, which is understood as November 23, 1983; provided, however, that the term of this Franchise shall be considered extended concurrent with proper exercise of the option to renew provided for in the Navy Contract, provided, however, that the City shall reserve the right not to extend this agreement in the event Grantee fails to comply with any material provision of this ordinance.

Section 2. All other provisions of Ordinance Number O-16068 remain in full force and effect.

Section 3. This ordinance shall take effect and be in force on the thirtieth day from and after its passage.
