

ORDINANCE NUMBER O- 16631 (NEW SERIES)

ADOPTED ON APR 28 1986

AN ORDINANCE INCORPORATING A 1.86-ACRE SITE LOCATED ON THE SOUTH SIDE OF UNIVERSITY AVENUE, BETWEEN MISSISSIPPI AND LOUISIANA STREETS, DESCRIBED AS BLOCK 3 OF PAULY'S ADDITION, MAP 65, AND PORTIONS OF LOUISIANA AND MISSISSIPPI STREETS VACATED, IN THE PARK NORTHEAST COMMUNITY PLAN AREA, IN THE CITY OF SAN DIEGO, CALIFORNIA, INTO CA ZONE, AS DEFINED BY SECTION 101.0428.1 OF THE SAN DIEGO MUNICIPAL CODE, AND REPEALING ORDINANCE NO. 11538 (NEW SERIES), ADOPTED APRIL 4, 1975, AND ORDINANCE NO. 12889, APPROVED JULY 7, 1930, OF THE ORDINANCES OF THE CITY OF SAN DIEGO INsofar AS THE SAME CONFLICT HEREWITH.


BE IT ORDAINED, by the Council of The City of San Diego, as follows:

Section 1. That a 1.86-acre site located on the south side of University Avenue, between Mississippi and Louisiana Streets, described as Block 3, Pauly's Addition, Map 65, and portions of Louisiana and Mississippi Streets vacated, in the Park Northeast Community Plan area, in The City of San Diego, California, within the boundary of the district designated "CA" on Zone Map Drawing No. B-3706, filed in the office of the City Clerk as Document No. 769158, be, and it is hereby incorporated into CA Zone, as such zone is described and defined by Section 101.0428.1 of the San Diego Municipal Code.

Section 2. That Ordinance No. 11538 (New Series), adopted April 4, 1975, and Ordinance No. 12889, approved July 7, 1930, of the ordinances of The City of San Diego be and they are hereby repealed insofar as they conflict herewith.

Section 3. This ordinance shall take effect and be in force on the thirtieth day from and after its passage, and no building permits for development inconsistent with the provisions of this ordinance shall be issued unless application therefor was made prior to the date of adoption of this ordinance.
