AN ORDINANCE AMENDING CHAPTER VI, ARTICLE 1, DIVISION 20, OF THE SAN DIEGO MUNICIPAL CODE BY AMENDING SECTION 61.2004 RELATING TO THE SAN DIEGO PARK FACILITIES DISTRICT PROCEDURAL ORDINANCE.

BE IT ORDAINED, by the Council of The City of San Diego, as follows:

Section 1. That Chapter VI, Article 1, Division 20, of the San Diego Municipal Code be and the same is hereby amended by amending Section 61.2004 to read as follows:

SEC. 61.2004 PROCEDURE

Excepting as to matters therein inconsistent with the intent, purposes and provisions of this Division, the provisions of the Community Facilities Law of 1911 (commencing with Section 4600, Part 3, Division 5, Health and Safety Code), excepting Article 2a, subdivision (d) of Section 4616, the first sentence of Section 4618, the first sentence of Section 4623, Sections 4623.5, 4625 and the last sentence of Section 4638, thereof, and the provisions of Article 9 (commencing with Section 53550), as modified by Article 11 (commencing with Section 53580), Chapter 3, Part 1, Division 2, Title 5, Government Code, excepting Section 53569, thereof, shall apply to the formation and government of such districts.

Section 2. This ordinance shall take effect and be in force on the thirtieth day from and after its passage.
