AN ORDINANCE AMENDING CHAPTER VIII, ARTICLE 2, OF THE SAN DIEGO MUNICIPAL CODE BY AMENDING SECTION 82.07 RELATING TO PARKING VIOLATIONS.

BE IT ORDAINED, by the Council of The City of San Diego, as follows:

Section 1. That Chapter VIII, Article 2, of the San Diego Municipal Code be and the same is hereby amended by amending section 82.07 to read as follows:

SEC. 82.07 PARKING VIOLATIONS

- (a) No change.
- (b) Fees

For the purpose of regulating the use of streets and traffic thereon and as a deterrent to illegal parking, and to recover administrative costs, the following fees are established:
