AN ORDINANCE AMENDING ORDINANCE NO. O-16475 (NEW SERIES), AS AMENDED, ENTITLED "ANORDINANCE ADOPTING THE ANNUAL BUDGET FOR THE FISCAL YEAR 1985-86 AND APPROPRIATING THE NECESSARY MONEY TO OPERATE THE CITY OF SANDIEGO FOR SAID FISCAL YEAR" BY AMENDING DOCUMENT NO. OO-16475-1, AS AMENDED AND ADOPTED THEREIN, BY ADDING TO SECTION 2.I. A NEW DEPARTMENT OF BINATIONAL AFFAIRS; AND TRANSFERRING THE SUM OF \$16,650 IN THE GENERAL FUND 100 FROM THE UNALLOCATED RESERVE (605) FOR THE PURPOSE OF FUNDING SAID NEWLY CREATED DEPARTMENT.

WHEREAS, the City Council has determined that it is necessary and appropriate to establish a Department of Binational Affairs; and

WHEREAS, the City Manager has background and discussion on such matter in his Report No. 86-150, dated April 2, 1986 and has recommended the creation of such department; and

WHEREAS, the supplementary information in respect to the entire matter is set forth in the April 23, 1986 memorandum from the Deputy Mayor to the City Council, with the recommendation that the new department be under the direction and control of the City Manager; and

WHEREAS, the Rules Committee considered said matter and has forwarded it to the full Council with no recommendation on a unanimous vote; NOW, THEREFORE,

BE IT ORDAINED, by the Council of The City of San Diego, as follows:

Section 1. That Ordinance No. O-16475 (New Series), as amended, entitled "AN ORDINANCE ADOPTING THE ANNUAL BUDGET FOR THE FISCAL YEAR 1985-86 AND APPROPRIATING THE NECESSARY MONEY TO OPERATE THE CITY OF SAN DIEGO FOR SAID FISCAL YEAR," be and the same is hereby amended by amending Document No. OO-16475-1, as amended and adopted therein, by adding to Section 2.I. [General Fund 100] a new Department of Binational Affairs.

Section 2 That there be and is hereby authorized to be included in the personnel authorization of said newly authorized department two (2.0) positions consisting of a department director and assistant director.

Section 3. That the Auditor and Comptroller be and he is hereby authorized and directed to transfer within the General Fund 100 the sum of \$16,650 from the Unallocated Reserve (605) to the newly created department for the purpose of fully funding the above authorized positions and any related nonpersonnel expenses for the remainder of fiscal year 1986.

Section 4. That the City Attorney be and he is hereby directed to amend the annual salary ordinance, as required, to include within the Executive category of the Unclassified Service the classifications of Director and Assistant Director of Binational, Affairs.

Section 5. This ordinance shall take effect and be in force immediately upon its adoption after two (2) public hearings, pursuant to the authority contained in sections 16, 17 and 71 of the Charter of The City of San Diego; provided, however, that any action relating to the Director and Assistant Director of

Binational Affairs shall not be taken until such time as said classifications are legally established.
