BE IT ORDAINED, by the Council of The City of San Diego, as follows:

Section 1. That Chapter II, Article 2, Section 22.1801 of the San Diego Municipal Code be and the same is hereby amended to read as follows:

SEC. 22.1801 CITY DEPARTMENTS

- a. Purpose and Intent. It is the purpose and intent of the City Council to enumerate the existing departments of the City because of repeated reference in City legislation and operation to such departments.
- b. The following are the departments of The City of San Diego within the meaning of the Charter and ordinances of said City:

The department head for each department of City Council

- Districts 1 through 8 shall be the duly elected and/or appointed Councilman or Councilwoman from the district.

Section 2. This ordinance shall take effect and be in force on the thirtieth day from and after its passage.
