AN ORDINANCE AMENDING CHAPTER II, ARTICLE 2,  
OF THE SAN DIEGO MUNICIPAL CODE BY AMENDING  
SECTION 22.1801 RELATING TO THE DEPARTMENTS OF  
THE CITY OF SAN DIEGO.

WHEREAS, it is proposed that a Department of Binational  
Affairs be created under the direction of the City Manager; and

WHEREAS, concurrent with the establishment of said  
department, it is also necessary to amend the listing of the City  
Departments; NOW, THEREFORE,

BE IT ORDAINED, by the Council of The City of San Diego, as  
follows:

Section 1. That Chapter II, Article 2, Section 22.1801 of  
the San Diego Municipal Code be and the same is hereby amended to  
read as follows:

SEC. 22.1801 CITY DEPARTMENTS

a. Purpose and Intent. It is the purpose and intent of  
the City Council to enumerate the existing departments of the  
City because of repeated reference in City legislation and  
operation to such departments.

b. The following are the departments of The City of San  
Diego within the meaning of the Charter and ordinances of  
said City:


