AN ORDINANCE AMENDING CHAPTER X, ARTICLE 3,  
DIVISION 15, OF THE SAN DIEGO MUNICIPAL CODE  
BY AMENDING SECTION 103.1501 RELATING TO THE  
MID-CITY PLANNED DISTRICT.

BE IT ORDAINED, by the Council of The City of San Diego, as follows:

Section 1. That Chapter X, Article 3, Division 15, of the San Diego Municipal Code be and the same is hereby amended by amending Section 103.1501 to read as follows:

**SEC. 103.1501 BOUNDARIES**

The regulations which follow shall apply in the areas of the Mid-City Community Planning Area in the City of San Diego, California, designated on those certain map Drawing Nos. C-706.1 and C-712 (an amendment to C-706.1), and described in the appended boundary descriptions filed in the office of the City Clerk under Document Nos. 00-16576 and

00-16646.

Section 2. This ordinance shall take effect and be in force on the thirtieth day from and after its passage.
