AN ORDINANCE AMENDING ORDINANCE NO. 16434 (NEW SERIES), AS AMENDED, ENTITLED "AN ORDINANCE ESTABLISHING A SCHEDULE OF COMPENSATION FOR OFFICERS AND EMPLOYEES OF THE CITY OF SAN DIEGO FOR THE FISCAL YEAR 1985-86" TO CREATE THE NEW POSITIONS OF DIRECTOR AND ASSISTANT DIRECTOR OF BINATIONAL AFFAIRS; AMENDING EXHIBIT C TO SAID ORDINANCE TO INCLUDE SAID POSITIONS; ESTABLISHING SALARY RATES THEREFOR.

WHEREAS, on April 28, 1986, the City considered the matter of establishing a Department of Binational Affairs within the General Fund 100, to be placed under the control of and supervision by the City Manager; and

WHEREAS, the City Manager presented the background and discussion on the matter in his Report No. 86-150, dated April 2, 1986; and

WHEREAS, the Council approved the introduction of an ordinance on April 28, 1986 to establish said department, with the adoption to occur May 12, 1986 and effective date to be thirty days thereafter; and

WHEREAS, said department will be staffed with a Director and Assistant Director; and

WHEREAS, it is necessary to amend the annual salary ordinance to create said positions and establish appropriate rates of compensation therefor; NOW, THEREFORE,

BE IT ORDAINED, by the Council of The City of San Diego, as follows:

Section 1. That Ordinance No. 16434 (New Series), as amended entitled "AN ORDINANCE ESTABLISHING A SCHEDULE OF COMPENSATION FOR OFFICERS AND EMPLOYEES OF THE CITY OF SAN DIEGO FOR THE FISCAL YEAR 1985-86" be and the same is hereby further amended by creating and establishing the positions of Director and Assistant Director of the Binational Affairs Department.

Section 2. That said Ordinance No. 16434 (New Series) be and it is fiereby further amended to amend Exhibit C thereto so as to reflect said position designation of Director of Binational Affairs in Executive Category III and Assistant Director of Binational Affairs in Executive Category II.

Section 3. As a schedule of compensation for the positions established and enumerated in sections 1 and 2 above, the positions of Director of Binational Affairs is hereby authorized at salary ranges 03.0, 03.1 and 03.2; and the position of Assistant Director is hereby authorized at salary ranges 02.0 and 02.1

Section 4. This ordinance shall take effect and be in force on the thirtieth day from and after its passage.
