ADOPTED ON MAY 27 1986

AN ORDINANCE INCORPORATING A PORTION OF RANCHO DE LOS PENASQUITOS, PARCELS 1 AND 2 AND A PORTION OF PARCEL 3, PARCEL MAP NO. 12296, AND A PORTION OF SECTION 20, TOWNSHIP 14 SOUTH, RANGE 2 WEST, S.B.B.M., LOCATED ON THE SOUTH SIDE OF PENASQUITOS CANYON WEST OF INTERSTATE 15, AND EXTENDING TO A POINT ABOUT 1,000 FEET WEST OF BLACK MOUNTAIN ROAD, IN THE MIRA MESA COMMUNITY PLAN AREA, IN THE CITY OF SAN DIEGO, CALIFORNIA, INTO R1-10000 ZONE, AS DEFINED BY SECTION 101.0410 OF THE SAN DIEGO MUNICIPAL CODE, AND REPEALING ORDINANCE NO. 8782 (NEW SERIES), ADOPTED JANUARY 31, 1963, AND ORDINANCE NO. 8858 (NEW SERIES), ADOPTED JULY 18, 1963, OF THE ORDINANCES OF THE CITY OF SAN DIEGO INSOFAR AS THE SAME CONFLICT HEREWITH.

BE IT ORDAINED, by the Council of The City of San Diego, as follows:

Section 1. That in the event that within three years of the effective date of this ordinance a portion of Rancho de los Penasquitos, Parcels 1 and 2 and a portion of Parcel 3, Parcel Map No. 12296, and a portion of Section 20, Township 14 South, Range 2 West, S.B.B.M., located on the south side of Penasquitos Canyon, west of Interstate 15, and extending to a point about 1,000 feet west of Black Mountain Road, in the Mira Mesa Community Plan area, in the City of San Diego, California, designated "R1-10000" on Zone Map Drawing No. B-3726, is subdivided and a map or maps thereof duly submitted to the City and thereafter recorded, and within such subdivision or subdivisions provision is made for the installation of public

easements for public use, the provisions of Section 101.0410 shall attach and become applicable to the said subdivided land, and the said subdivided land shall be incorporated into R1-10000 Zone, as described and defined by Section 101.0410, the boundary of such zone to be as indicated on Zone Map Drawing No. B-3726, filed in the office of the City Clerk as Document No. 769339. Said zoning shall attach only to those areas included in the map as provided in this section.

Section 2. That in the event the zoning restrictions shall attach to the said land described in Section 1 of this ordinance, Ordinance No. 8782 (New Series), adopted January 31, 1963, and Ordinance No. 8858 (New Series), adopted July 18, 1963, be, and they are hereby repealed insofar as they conflict herewith.

Section 3. This ordinance shall take effect and be in force on the thirtieth day from and after its passage, and no building permits for development inconsistent with the provisions of this ordinance shall be issued unless application therefor was made prior to the date of adoption of this ordinance.
