AN ORDINANCE INCORPORATING LOTS 35 AND 36, BLOCK 6, SAN DIEGO LAND AND TOWN, SOUTH CHOLLAS ADDITION, MAP NO. 579, LOCATED ON THE SOUTH SIDE OF NATIONAL AVENUE BETWEEN 35TH AND 36TH STREETS, IN THE SOUTHEAST SAN DIEGO COMMUNITY PLAN AREA, IN THE CITY OF SAN DIEGO, CALIFORNIA, INTO CA ZONE, AS DEFINED BY SECTION 101.0428 OF THE SAN DIEGO MUNICIPAL CODE, AND REPEALING ORDINANCE NO. O-15110 (NEW SERIES), ADOPTED DECEMBER 3, 1979, OF THE ORDINANCES OF THE CITY OF SAN DIEGO INSOFAR AS THE SAME CONFLICTS HEREWITH.
