This Ordinance repeals Section 101.0506.9 F of the San Diego Municipal Code which established the date of July 1, 1986 as the expiration date of Ordinance Number 16373 (New Series) Adopted on February 19, 1985. The adoption of this Ordinance will make permanent Ordinance Number 16373 which created the requirement of a Conditional Use Permit for moved buildings.
