ORDINANCE NUMBER 0-16659

ADOPTED ON JUN 2 1986

AN ORDINANCE INCORPORATING LOTS A-112 AND A-113, ADDITION NO. 1 OF SAN YSIDRO, MAP NO. 1194 (A 2.105-ACRE SITE), LOCATED ON THE WEST SIDE OF WILLOW ROAD, BETWEEN CALLE PRIMERA AND CAMINO DE LA PLAZA, IN THE TIA JUANA RIVER VALLEY PLAN AREA, IN THE CITY OF SAN DIEGO, CALIFORNIA, INTO R-1500 ZONE, AS DEFINED BY SECTION 101.0410 OF THE SAN DIEGO MUNICIPAL CODE, AND REPEALING ORDINANCE NO. 10862 (NEW SERIES), ADOPTED JUNE 15, 1972, OF THE ORDINANCES OF THE CITY OF SAN DIEGO INSOFAR AS THE SAME CONFLICTS HEREWITH.

BE IT ORDAINED, by the Council of The City of San Diego, as follows:

Section 1. That Lots 112 and 113, Addition No. 1, San Ysidro, Map No. 1194 (a 2.105-acre site), located on the west side of Willow Road, between Calle Primera and Camino de la Plaza, in the Tia Juana River Valley Plan area, in The City of San Diego, California, within the boundary of the district designated R-1500 on Zone Map Drawing No. B-3705.1, filed in the office of the City Clerk as Document No. 769350 , be, and it is hereby incorporated into R-1500 Zone, as such zone is described and defined by Section 101.0410 of the San Diego Municipal Code.

Section 2. That Ordinance No. 10862 (New/Series), adopted June 15, 1972, of the ordinances of The City of San Diego be and it is hereby repealed insofar as it conflicts herewith.

Section 3. This ordinance shall take effect and be in force on the thirtieth day from and after its passage, and no building permits for development inconsistent with the provisions of this ordinance shall be issued unless application therefor was made prior to the date of adoption of this ordinance.
