BE IT ORDAINED, by the Council of The City of San Diego, as follows:

Section 1. That Fairmont Addition, Block 4, Lots 1 through 4, and 96 through 99; Block 5, Lots 1 through 4, and 67 through 70; Block 6, Lots 1 through 4 and 22 through 23, Map No. 1347; Fairhaven Acres, Lot 1, Map No. 1490; Bellecrest Subdivision, Block E, Lots 10 through 18; Block D, Lots 13 and 14, Map No. 1561; Mountain View, Block 5, Lots 25 through 48, Map No. 1147, located on Euclid Avenue, between Wightman and Dwight Streets, and that Bellview Center Unit 2, Block 3, Lots 2 and 3; Block 4, Lots 1 through 3, Map No. 3010; Parcel 2, Parcel Map No. 8127; Parcel Map 9821, located on Bates Street, both in the ~~Mid-City~~ Community Plan area, in the City of San Diego, California, within the boundaries designated on Zone Map Drawing No. C-706.2, filed in the office of the City Clerk as Document No. 00-16661, be, and they are hereby incorporated into the Mid-City Planned District; that portion on Euclid Avenue to the CL-2 Zone and that portion on Bates Street to the MR-1500 Zone, as such zones are described and defined by Section 103.1500 of the San Diego Municipal Code.

Section 2. That pertinent ordinances of ~~The~~ City of San Diego be and they are hereby repealed insofar as they conflict herewith.

Section 3. This ordinance shall take effect and be in force on the thirtieth day from and after its passage, and no building permits for development inconsistent with the provisions of this ordinance shall be issued unless application therefor was made prior to the date of adoption of this ordinance.
