
AN ORDINANCE APPROVING THE TERMS AND CONDITIONS AND AUTHORIZING THE EXECUTION OF AGREEMENT NO. 35-044-85-70-A WITH THE STATE COASTAL CONSERVANCY.

BE IT ORDAINED, by the Council of The City of San Diego, as follows:

Section 1. That the terms and conditions authorizing the execution of Agreement No. 85-044-85-70-A with the State Coastal Conservancy for a grant not to exceed \$120,960 to subsidize the construction of Ocean Boulevard Improvements - Phase 2, on file in the office of the City Clerk as Document No. 00- 16666, are hereby approved.

Section 2. This ordinance shall take effect and be in force on the thirtieth day from and after its passage.
