AN ORDINANCE AMENDING ORDINANCE NO. O-16475 (NEW SERIES), AS AMENDED, ENTITLED "AN ORDINANCE ADOPTING THE ANNUAL BUDGET FOR THE FISCAL YEAR 1985-86 AND APPROPRIATING THE NECESSARY MONEY TO OPERATE THE CITY OF SAN DIEGO FOR SAID FISCAL YEAR" BY AMENDING DOCUMENT NO. OO-16475-1, AS AMENDED AND ADOPTED THEREIN, BY AMENDING THE PERSONNEL AUTHORIZATION OF THE PLANNING DEPARTMENT (065), IN GENERAL FUND 100, BY ADDING ONE (1.00) PRINCIPAL PLANNER POSITION; EXEMPTING SAID PRINCIPAL PLANNER POSITION FROM THE CLASSIFIED SERVICE; AND ESTABLISHING A SALARY RATE THEREFOR.

WHEREAS, on May 27, 1986, the City Council adopted an ordinance providing a city-wide landscape program; and

WHEREAS, pursuant to the Council action in adopting that ordinance, the City Council also authorized the addition of one (1.00) Principal Planner position to the Planning Department (065) for the purpose of assuming primary responsibility for the Landscape Ordinance Program (06541); and

WHEREAS, it has been further requested that the newly authorized Principal Planner position be exempted from the Classified Service and placed in the Unclassified Service; and

WHEREAS, section 117(a)17 of the Charter provides that "managerial employees having significant responsibilities for formulating or administering departmental policies and programs" may be exempted from the Classified Service by ordinance upon first having been reviewed and commented upon by the Civil Service Commission; and

WHEREAS, the Civil Service Commission reviewed this request on June 5,.1986 and has commented unfavorably upon the exemption as meeting the criteria set forth in the Charter; and

WHEREAS, it is now necessary to amend the annual appropriation ordinance to effectuate said addition and exemption from the Classified Service; NOW, THEREFORE,

BE IT ORDAINED, by the Council of The City of San Diego, as follows:

Section 1. That Ordinance No. O-16475 (New Series), as amended, entitled "AN ORDINANCE ADOPTING THE ANNUAL BUDGET FOR THE FISCAL YEAR 1985-86 AND APPROPRIATING THE NECESSARY MONEY TO OPERATE THE CITY OF SAN DIEGO FOR SAID FISCAL YEAR," be and the same is hereby amended by amending Document No. OO-16475-1, as adopted and amended therein, by adding one (1.00) Principal Planner position to the personnel authorization of the Planning Department (065).

Section 2. That pursuant to section 117(a)17 of the City Charter, after having been reviewed and commented upon unfavorably by the Civil Service Commission on June 5, 1986, the Principal Planner position authorized herein is hereby exempted from the Classified Service and declared to be in the Unclassified Service of The City of San Diego.

Section 3. As a schedule of compensation for the unclassified position created in sections 1 and 2 hereof, the salary rate set forth in Salary Rates 7.7, 7.8 and 7.9 of the Table of Classifications and Standard Salary Rates under Managerial Category C, identified as Exhibit C to Ordinance No.

O-16434 (New Series), dated May 28, 1985, be and the same is hereby adopted.

Section 4. This ordinance shall take effect and be in force immediately upon its adoption after two (2) public hearings, pursuant to the authority contained in sections 16, 17 and 71 of the Charter of The City of San Diego.
