AN ORDINANCE AMENDING ORDINANCE NO. O-16475 (NEW SERIES), AS AMENDED, ENTITLED "AN ORDINANCE ADOPTING THE ANNUAL BUDGET FOR THE FISCAL YEAR 1985-86 AND APPROPRIATING THE NECESSARY MONEY TO OPERATE THE CITY OF SAN DIEGO FOR SAID FISCAL YEAR" BY AMENDING DOCUMENT NO. OO-16475-1, AS AMENDED AND ADOPTED THEREIN, BY APPROPRIATING THE ADDITIONAL SUM OF \$20,000 FROM AVAILABLE SALES TAX REVENUES TO THE CONTRIBUTION TO THE REDEVELOPMENT AGENCY FUND (10227) FOR THE PURPOSE OF PAYING ADMINISTRATIVE EXPENSES OF SOUTHEAST ECONOMIC DEVELOPMENT CORPORATION.


BE IT ORDAINED, by the Council of The City of San Diego, as follows:

Section 1. That Ordinance No. O-16475 (New Series), as amended, entitled "AN ORDINANCE ADOPTING THE ANNUAL BUDGET FOR THE FISCAL YEAR 1985-86 AND APPROPRIATING THE NECESSARY MONEY TO OPERATE THE CITY OF SAN DIEGO FOR SAID FISCAL YEAR," be and the same is hereby amended by amending Document No. OO-16475-1, as amended and adopted therein, by appropriating the additional sum of \$20,000 from available sales tax revenues to the Contribution to the Redevelopment Agency Fund (10227).

Section 2. That the City Auditor and Comptroller is hereby authorized to allocate said sum of \$20,000 from the Contribution to the Redevelopment Agency Fund (10227) the Southeast Economic Development Corporation for the purpose of disbursing to and paying administrative expenses of Southeast Economic Development Corporation which have been rule ineligible for CDBG funds.

Section 3. This ordinance shall take effect and be in force immediately upon its adoption after two (2) public hearings, pursuant to the authority contained in sections 16, 17 and 71 of the Charter of The City of San Diego.


