AN ORDINANCE INCORPORATING LOTS 26 THROUGH 50, BLOCK 2, LOTS 1 THROUGH 50, BLOCK 9, LOTS 1 THROUGH 12, BLOCK 10, LOTS 24 AND 25 AND PORTIONS OF LOTS 21, 22, 23, AND 26 THROUGH 30, BLOCK 12, CRITTENDEN'S ADDITION, MAP 303, LOCATED ON THE EAST AND WEST SIDES OF SEVENTH AVENUE, BETWEEN BROOKES AVENUE AND UPAS STREET, IN THE UPTOWN COMMUNITY PLAN AREA, IN THE CITY OF SAN DIEGO, CALIFORNIA, INTO R1-8000 ZONE, AS DEFINED BY SECTION 101.0407 OF THE SAN DIEGO MUNICIPAL CODE, AND REPEALING ORDINANCE NO. 12988, APPROVED OCTOBER 20, 1930, OF THE ORDINANCES OF THE CITY OF SAN DIEGO INSOFAR AS THE SAME CONFLICTS HEREWITH.

BE IT ORDAINED, by the Council of The City of San Diego, as follows:

Section 1. That Lots 26 through 50, Block 2, Lots 1 through 50, Block 9, Lots 1 through 12, Block 10, Lots 24 and 25, and portions of Lots 21, 22, 23, and 26 through 30, Black 12, Crittenden's Addition, Map 303, located on the east and west sides of Seventh Avenue, in the Uptown Community Plan area, in The City of San Diego, California, within the boundary of the district designated "R1-8000" on Zone Map Drawing No. B-3781, filed in the office of the City Clerk as Document No.

769352, be, and they are hereby incorporated into R1-8000 Zone, as such zone is described and defined by Section 101.0407 of the San Diego Municipal Code.

That Ordinance No. 12988, approved October 20, 1930, of the ordinances of The City of San Diego be and it is hereby repealed insofar as it conflicts herewith.

Section 3. This ordinance shall take effect and be in force on the thirtieth day from and after its passage, and no building permits for development inconsistent with the provisions of this ordinance shall be issued unless application therefor was made prior to the date of adoption of this ordinance.
