AN ORDINANCE AMENDING ORDINANCE NO. 0-16649 (NEW SERIES), AS AMENDED, ENTITLED "AN ORDINANCE, ESTABLISHING A SCHEDULE OF COMPENSATION FOR OFFICERS AND EMPLOYEES OF THE CITY OF SAN DIEGO FOR THE FISCAL YEAR 1986-87," BY AMENDING DOCUMENT NO. 00-16649-1, AS AMENDED AND ADOPTED THEREIN, BY CREATING A NEW POSITION ENTITLED "ASSISTANT STADIUM MANAGER"; EXEMPTING SAID ASSISTANT STADIUM MANAGER POSITION FROM THE CLASSIFIED SERVICE; AMENDING EXHIBIT C TO SAID ORDINANCE TO INCLUDE THE CLASSIFICATION OF ASSISTANT STADIUM MANAGER; AND ESTABLISHING A SALARY RATE THEREFOR.

WHEREAS, the Assistant Stadium Manager assumes the duties (now performed by Assistant Facility Manager) of the Stadium Manager (an unclassified position) in the Stadium Manager's absence and performs all the duties associated therewith; and

WHEREAS, the duties of the Assistant Stadium Manager are comparable to those of other assistant department heads and deputy directors which have been placed in the Unclassified Service; and

WHEREAS, it is now requested that the position of Assistant Stadium Manager also be placed in the Unclassified Service; and

WHEREAS, section 117(a)17 of the Charter provides that "managerial employees having significant responsibilities for formulating or administering departmental policies and programs" may be exempted from the Classified Service by ordinance upon first having been reviewed and commented upon by the Civil Service Commission: and

WHEREAS, the Civil Service Commission reviewed this request on June 5, 1986 and has commented favorably upon the exemption as meeting the criteria set forth in the Charter; and

WHEREAS, it is now necessary to amend the annual salary ordinance to create said position and effectuate said exemption from the Classified Service; NOW, THEREFORE,

BE IT ORDAINED, by the Council of The City of San Diego, as follows:

Section 1. That Ordinance No. O-16649 (New Series), as amended, entitled "AN ORDINANCE ESTABLISHING A SCHEDULE OF COMPENSATION FOR OFFICERS AND EMPLOYEES OF THE CITY OF SAN DIEGO FOR THE FISCAL YEAR 1986-87" be and the same is hereby amended by amending Document No. OO-16649-1, as adopted and amended therein, by creating a new Assistant Stadium Manager position to replace the heretofore used classification of Assistant Facility Manager in the San Diego Operating Fund (93010).

Section 2. That pursuant to section 117(a) 17 of the City
Charter, after having been reviewed and commented upon favorably
by the Civil Service Commission on June 5, 1986, the Assistant
Stadium Manager position authorized herein is hereby exempted
from the Classified Service and declared to be in the
Unclassified Service of The City of San Diego.

Section 3. As a schedule of compensation for the unclassified position created and added in sections 1 and 2 hereof, the salary rate set forth in Salary Rates 7.7, 7.8 and 7.9 of the Table of Classifications and Standard Salary Rates under Managerial Category C, identified as Exhibit C to Ordinance

No. 0-16649 (New Series), dated May 27, 1986, be and the same is hereby adopted.

Section 4. This ordinance shall take effect and be in force on the thirtieth day from and after its passage.
