That portions of Lots 1 and 2, Map 839, a partition of Pueblo Lot 1783, generally described as those properties bounded by La Jolla Boulevard on the west, Turquoise Street on the south, the alley west of La Jolla Mesa Boulevard on the east, and the La Jolla community on the north, in the Pacific Beach Community Plan area, in the City of San Diego, California, within the boundary of the district designated "Community Plan Implementation Overlay Zone" on Zone Map Drawing No. B-3737.1, filed in the office of the City Clerk as Document No. 769369, be, and it is hereby incorporated into Community Plan Implementation Overlay Zone, as such zone is described and defined by Sections 101.0457 of the San Diego Municipal Code.

Section 2. The property described above has been found by the City Council to meet Criterion B of Municipal Code Section 101.0457.2 and applications for development within the area shall be considered "Type B" applications.

Section 3. This ordinance shall take effect and be in force on the thirtieth day from and after its passage, and no building permits for development inconsistent with the provisions of this ordinance shall be issued unless application therefor was made prior to the date of adoption of this ordinance.
