AN ORDINANCE AMENDING ORDINANCE NO. 0-16649 (NEW SERIES), AS AMENDED, ENTITLED "AN ORDINANCE ESTABLISHING A SCHEDULE OF COMPENSATION FOR OFFICERS AND EMPLOYEES OF THE CITY OF SAN DIEGO FOR THE FISCAL YEAR 1986-87," BY AMENDING DOCUMENT NO. 00-16649-1, AS AMENDED AND ADOPTED THEREIN, BY CREATING TWO (2) NEW CLASSIFICATIONS ENTITLED FIRE RECRUIT AND FIRE FIGHTER I; AMENDING THE CLASSIFICATION TITLE OF FIRE FIGHTER AS PRESENTLY EXISTS TO FIRE FIGHTER II; AMENDING EXHIBIT B TO SAID ORDINANCE TO INCLUDE SAID NEW CLASSIFICATIONS UNDER THE FIRE CATEGORY; ESTABLISHING SALARY RATES THEREFOR, AND CHANGING THE TITLE OF FIREFIGHTER TO FIRE FIGHTER II IN SAID EXHIBIT B TO THE ORDINANCE; AND APPROVING OVERTIME ELIGIBILITY FOR SAID NEW CLASSES.

WHEREAS, on June 5, 1986, the Civil Service Commission approved a request from the City Manager's office to create two new classes within the Fire series and to retitle Fire Fighter to Fire Fighter II as part of a new career development program in the Fire Department; and

WHEREAS, the new program was developed to provide increased standardization of training consistent with Statewide standards developed by the State Fire Marshal; and

WHEREAS, by design, this program will also enable the department to evaluate the performance of trainees more effectively through a more structured review of tasks; and

WHEREAS, the salary range for Fire Recruit will be approximately \$1320 to \$1595 per month and for Fire Fighter I it

will be approximately \$1593 to \$1922 per month and the current classification of Fire Fighter be retitled to Fire Fighter II with no change in salary; and

WHEREAS, the fiscal year 1987 salary ordinance provides that the Civil Service Commission and the City Manager determine those classifications which would be eligible to receive overtime compensation and requires that these determinations be approved by Council; and

WHEREAS, it is recommended that the new classes of Fire Recruit and Fire Fighter I be eligible for premium rate overtime under the same conditions as the existing Fire Fighter class; NOW, THEREFORE,

BE IT ORDAINED, by the Council of The City of San Diego, as follows:

Section 1. That Ordinance No. O-16649 (New Series), as amended, entitled "AN ORDINANCE ESTABLISHING A SCHEDULE OF COMPENSATION FOR OFFICERS AND EMPLOYEES OF THE CITY OF SAN DIEGO FOR THE FISCAL YEAR 1986-87" be and the same is hereby amended by amending Document No. OO-16649-1, as adopted and amended therein, by creating two (2) new classifications in the Classified Service, Fire Category, to be entitled Fire Recruit and Fire Fighter I.

Section 2. That Exhibit B to said ordinance be and it is hereby amended to include said newly created classifications in the Fire Category at salary rates 46.3 and 46.1, respectively, and further, that the classification of Fire Fighter be retitled to read Fire Fighter II at no change in salary rate.

Section 3. That said new classes of Fire Recruit and Fire Fighter I be and they are hereby declared to be eligible for premium rate overtime under the same conditions as applies to the existing Fire Fighter class.

Section 4. This ordinance shall take effect and be in force on the thirtieth day from and after its passage.
