AN ORDINANCE AMENDING CHAPTER X, ARTICLE 2, DIVISION 4 OF THE SAN DIEGO MUNICIPAL CODE BY REPEALING SECTION 102.0406.06.3 RELATING TO PARK FEES IN THE TIERRASANTA COMMUNITY PLAN AREA.

WHEREAS, by Ordinance No. O-16129 New Series, San Diego
Municipal Code section 102.0406.06.3 relating to Park Fees in the
Tierrasanta Community Plan was enacted; and

WHEREAS, the City Council is contemplating the establishment of a Facilities Benefit Assessment District for the Tierrasanta Community Plan Area; and

WHEREAS, the City Council desires to assure that funds collected for park purposes in the Tierrasanta Community Plan Area are expended for the purposes originally contemplated; NOW, THEREFORE,

BE IT ORDAINED, by the Council of The City of San Diego, as follows:

Section 1. That Chapter X, Article 2, Division 4 of the San Diego Municipal Code be and the same is hereby amended by repealing section 102.0406.06.3 relating to Park Fees in the Tierrasanta Community Plan Area.

Section 2. That all funds that have been collected shall be deposited in the previously established special park fund for the Tierrasanta Community Plan Area. These funds and their interest earnings may be expended only for park and recreation projects identified for this community in its approved Financing Plan.

Section 3. That this ordinance shall become effective only upon the occurrence of both of the following conditions:

- (a) Thirty (30) days have elapsed from and after its passage.
