AN ORDINANCE AMENDING ORDINANCE NO. O-16678 (NEW SERIES), AS AMENDED, ENTITLED "AN ORDINANCE ADOPTING THE ANNUAL BUDGET FOR THE FISCAL YEAR 1986-87 AND APPROPRIATING THE NECESSARY MONEY TO OPERATE THE CITY OF SAN DIEGO FOR SAID FISCAL YEAR" BY AMENDING DOCUMENTS NO. OO-16678-1 AND NO. OO-16678-2, AS AMENDED AND ADOPTED THEREIN, BY AUTHORIZING THE EXPENDITURE OF \$78,940 FOR SANDER'S PERSONNEL EXPENSES FOR A DIRECT AND INTERMEDIATE TYPISTS; \$84,690 FOR NON-PERSONNEL EXPENSES INCLUDING CONTRACTUAL SERVICES AND ROUTINE OFFICE EXPENSES; AND PENDING A REVIEW BY THE PUBLIC SERVICES AND SAFETY COMMITTEE \$116,370 FOR PERSONNEL EXPENSES.

BE IT ORDAINED, by the Council of The City of San Diego, as follows:

Section 1. That Ordinance No. O-16678 (New Series), as amended, entitled "AN ORDINANCE ADOPTING THE ANNUAL BUDGET FOR THE FISCAL YEAR 1986-87 AND APPROPRIATING THE NECESSARY MONEY TO OPERATE THE CITY OF SAN DIEGO FOR SAID FISCAL YEAR," be and the same is hereby amended by amending Documents No. OO-16678-1 and No. OO-16678-2, as amended and adopted therein, to authorize the expenditure of \$78,940 for SANDER's personnel expenses for a director and intermediate typists; \$84,690 for nonpersonnel expenses including contractual services and routine office expenses; and pending a review by the Public Services and Safety Committee \$116,370 for personnel expenses, all as set forth in City Manager's Report No. 86-374.

Section 2. This ordinance shall take effect and be in force immediately upon its adoption after two (2) public hearings, pursuant to the authority contained in sections 16, 17 and 71 of the Charter of The City of San Diego.
