ADOPTED ON SEP 9 1986

AN EMERGENCY ORDINANCE PURSUANT TO SECTION 17 OF THE CHARTER OF THE CITY OF SAN DIEGO AMENDING CHAPTER V, ARTICLE 6, OF THE SAN DIEGO MUNICIPAL CODE BY AMENDING SECTION 56.54 PROHIBITING ALCOHOLIC BEVERAGE CONSUMPTION AND POSSESSION IN CERTAIN AREAS OF THE CITY OF SAN DIEGO.

WHEREAS, The City of San Diego, under the police power delegated to it by the Constitution of the State of California, has the authority to react when the potential exists for jeopardy to the public health, safety and general welfare of its citizens; and

WHEREAS, certain of The City of San Diego's beach area parking lots are experiencing substantial and increasing problems of aggressive and violent behavior, vandalism, reckless and drunk driving and littering; and

WHEREAS, police made 687 arrests in five of these beach area parking lots during just a six week period from June 1, 1986 to July 14, 1986; and

WHEREAS, it was determined that 49 percent of those arrests were alcohol-related; and

WHEREAS, there has been an increase in alcohol-related criminal activities and aggressive and/or offensive conduct by persons frequenting the below-listed areas; and

WHEREAS, City Manager's Report No. 86-419 dated September 5, 1986, a copy of which is on file with the Office of the City

Clerk as Document No. 00-19711, reflects the clear and convincing need for immediate action to relieve and reduce this problem; and

WHEREAS, many citizens of The City of San Diego fear to take their families to said areas for fear of harassment and/or violence; and

WHEREAS, it has been the experience of other coastal communities that prohibition of alcohol at their beaches results in decrease in criminal and undesirable behavior; and

WHEREAS, the situation herein described constitutes an emergency and the City Council finds that it is necessary for the immediate preservation of the public peace, property, health and safety to prohibit the consumption of alcoholic beverages or to possess an open container of any alcoholic beverage in certain public parking lots in the beach area and Mission Bay Park; NOW, THEREFORE,

BE IT ORDAINED, by the Council of The City of San Diego, as follows:

Section 1. That Chapter V, Article 6, Section 56.54 of the San Diego Municipal Code be, and the same is hereby amended to read as follows:

## SEC. 56.54 ALCOHOLIC BEVERAGE CONSUMPTION AND POSSESSION PROHIBITED IN CERTAIN AREAS

- [(a) No change.]
- (b) It shall be unlawful for any person without a permit duly issued by the City Manager for a special event to consume or to possess an open container of any alcoholic

beverage, as defined in Business and Professions Code section 23004, in the following areas of The City of San Diego:

- (1) All public parking lots within Mission Bay Park;
- (2) the West parking lot of the Jetty at 600 Block San Diego Place;
- (3) the parking areas around The Plunge and Belmont Park
  Roller Coaster at 3000 to 3200 Block Ocean Front Walk, 3000
  to 3200 Block Mission Boulevard and 700 Block Ventura Place;
- (4) the La Jolla Shores parking lot at 8100 to 8300 Block Camino del Oro;
- (5) the 600 Block Tourmaline Street;
  - (6) the 2200 to 2300 Block Bacon Street;
  - (7) the 5000 Block Voltaire Street;
  - (8) the 5000 Block Brighton Street;
  - (9) the 5000 Block Newport Street;
  - (10) the 1900 Block Abbott Street;
  - (11) the 1100 to 1300 Block Sunset Cliffs Boulevard;
  - (12) the 4500 Block Ladera Street.

Section 2. This ordinance is declared to be an emergency measure required for the immediate preservation of the public safety, health and welfare pursuant to Section 17 of the Charter of The City of San Diego and shall take effect immediately and

continue in force from the day of adoption thereof by two-thirds of the members of the City Council until October 30, 1986.
