ORDINANCE NUMBER O- 16714 (NEW SERIES)

ADOPTED ON SEP 22 1986

AN ORDINANCE AMENDING CHAPTER IX, ARTICLE 5, DIVISION 2, OF THE SAN DIEGO MUNICIPAL CODE BY AMENDING SECTIONS 95.0204, 95.0207, 95.0208 AND 95.0209 RELATING TO THE ASSIGNMENT OF BUILDING NUMBERS.

BE IT ORDAINED, by the Council of The City of San Diego, as follows:

Section 1. That Chapter IX, Article 5, Division 2, of the San Diego Municipal Code be and the same is hereby amended by amending Sections 95.0204, 95.0207, 95.0208 and 95.0209 to read as follows:

SEC. 95.0204 ONE HUNDRED NUMBERS PER BLOCK

Numbers shall be assigned on the general plan of 100 to each block; but where adjacent blocks are irregular in length, the numbers in these blocks or adjacent blocks may be varied to meet the conditions as determined by the Building Official, Building Inspection Department of The City of San Diego.

SEC. 95.0207 APPLICATION FOR HOUSE NUMBER

Before any permit shall be issued for building construction or any application for water filed with the Building Inspection Department the applicant for such permit or water connection shall obtain from the Building Official, Building Inspection Department, the proper house number for the lot for which such permit or water is desired.

SEC. 95.0208 AUTHORITY TO DETERMINE NUMBER

All numbers shall be allocated by the Building Official, Building Inspection Department, who shall determine the proper number in each case from maps to be numbered and maintained on file in the office of the Building Inspection Department.

SEC. 95.0209 OBTAINING AND POSTING OF NUMBER

House numbers as allotted by the Building Official, Building Inspection Department shall be placed on buildings on the transom over the principal entrance or on some other place on the front of the building where the number may be easily seen from the street and all such numbers shall be at least two and one-half (2½) inches in height.

It shall be the duty of the lessee, occupant or owner, of any building to obtain the proper house number from the Building Official, Building Inspection Department and to place such number on the building in question as required by this Division. And it shall be a violation of the Division to fail to so obtain and place the proper number.

Section 2. This ordinance shall take effect and be in force on the thirtieth day from and after its passage.
