
BE IT ORDAINED, by the Council of The City of San Diego, as follows:

Section 1. That Ordinance No. O-16678 (New Series), entitled "AN ORDINANCE ADOPTING THE ANNUAL BUDGET FOR THE FISCAL YEAR 1986-87 AND APPROPRIATING THE NECESSARY MONEY TO OPERATE THE CITY OF SAN DIEGO FOR SAID FISCAL YEAR" by amending Document No. OO-16678, as amended and adopted therein, by adding to the personnel authorization of the Planning Department (065) 1.00 Associate Planner transferring within the General Fund (100), the sum of \$41,884.00 from Unallocated Reserve (605) to the Planning Department (065) for the purpose of administering the Alcoholic Beverage Establishments Conditional Use Permit Ordinance.
