AN ORDINANCE AMENDING ORDINANCE NO. 0-16678 (NEW SERIES), AS AMENDED, ENTITLED "AN ORDINANCE ADOPTING THE ANNUAL BUDGET FOR THE FISCAL YEAR 1986-87 AND APPROPRIATING THE NECESSARY MONEY TO OPERATE THE CITY OF SAN DIEGO FOR SAID FISCAL YEAR" BY AMENDING DOCUMENT NO. 00-16678-1 AND 00-16678-2, AS AMENDED AND ADOPTED THEREIN, BY AMENDING THE PERSONNEL AUTHORIZATION OF THE PLANNING DEPARTMENT (065), IN GENERAL FUND 100, BY ADDING THREE (3.00) PRINCIPAL PLANNER POSITIONS THERETO AND DELETING ONE (1) SENIOR PLANNER, ONE (1) ASSOCIATE PLANNER, AND ONE (1) COMMUNITY DEVELOPMENT SPECIALIST IV; EXEMPTING SAID THREE (3.00) PRINCIPAL PLANNER POSITIONS FROM THE CLASSIFIED SERVICE; AND ESTABLISHING A SALARY RATE THEREFOR; AND CHANGING THE TITLES OF ONE EXISTING (1.00) PRINCIPAL PLANNER POSITION TO ASSISTANT TO THE PLANNING DIRECTOR, ONE (1.00) EXISTING ASSISTANT ZONING ADMINISTRATOR TO DEPUTY DIRECTOR AND ONE (1.00) EXISTING ASSISTANT TO THE PLANNING DIRECTOR TO PRINCIPAL PLANNER.

WHEREAS, on July 15, 1986, the City Council adopted an Annual budget for the Planning Department; and

WHEREAS, pursuant to the Council action in adopting that budget, the City Council also authorized the addition of forty and three-quarters (40.75) positions to the Planning Department (065) for the purpose of augmenting or adding 30 programs and implementing recommendations of the Planning Procedures studies; and

WHEREAS, the Planning Department has reorganized its previous four divisions under six operating divisions in order to implement the budget augmentation and Planning Procedure study; and

WHEREAS, the Planning Department reorganization and Fiscal
1987 Work Program includes six proposed personnel changes which
required Civil Services Commission review and comment and Council
authorization; and

WHEREAS, it has been requested that the titles of the three (3.00) existing unclassified positions be changed as indicated and retained in the unclassified service; and

WHEREAS, it has been further requested that the three (3.00) newly authorized Principal Planner positions be exempted from the Classified Service and placed in the Unclassified Service; and

WHEREAS, Section 117(a)17 of the Charter provides that
"managerial employees having significant responsibilities for
formulating or administering departmental polices and programs"
may be exempted from the Classified Service by ordinance upon
first having been reviewed and commented upon by the Civil
Service Commission; and

WHEREAS, the Civil Service Commission reviewed this request on August 7, 1986 and September 4, 1986, and has commented unfavorably upon the exemptions as meeting the criteria set forth in the Charter; and

WHEREAS, it was agreed between the Planning and Personnel
Departments, as set forth in the September 22, 1986 report to the
Transportation and Land Use Committee, that all Principal Planner
positions would be reinstated in the Classified Service effective
July 1, 1987 by action of the Council upon sufficient
justification and report thereon by the Personnel Department and
Civil Service Commission; and

WHEREAS, it is now necessary for the Council to amend the annual appropriation ordinance to effectuate said title changes, additions and any applicable exemptions as determined by Council from the Classified Service; NOW, THEREFORE,

BE IT ORDAINED, by the Council of The City of San Diego, as follows:

That Ordinance No. 0-16678 (New Series), as amended, entitled "AN ORDINANCE ADOPTING THE ANNUAL BUDGET FOR THE FISCAL YEAR 1986-87 AND APPROPRIATING THE NECESSARY MONEY TO OPERATE THE CITY OF SAN DIEGO FOR SAID FISCAL YEAR," be and the same is hereby amended by amending Document No. 00-16678-1 and 00-16678-2, as adopted and amended therein, by: deleting one (1.00) Principal Planner position and adding (1.00) Assistant to the Planning Director position; deleting one (1.00) Assistant Zoning Administrator position and adding one (1.00) Deputy Director position; deleting one Assistant to the Planning Director position and adding one (1.00) Principal Planner Position; deleting one (1.00) Senior Planner Position and adding one (1.00) Principal Planner position; deleting one (1.00) Associate Planner Position and adding one (1.00) Principal Planner Position; and deleting one (1.00) Community Development Specialist IV position and adding one (1.00) Principal Planner position to the personnel authorization of the Planning Department.

Section 2. That pursuant to Section 117(a)17 of the City Charter, after having been reviewed and commented upon unfavorably by the Civil Service Commission on August 7, 1986,

the Deputy Director, Assistant to Planning Director, and four Principal Planner positions authorized herein be and there are hereby declared to be exempt from the Classified Service and declared to be in the Unclassified Service of The City of San Diego.

Section 3. As a schedule of compensation for the unclassified positions created in Sections 1 and 2 hereof, the salary rate set forth in Salary Rates 7.7, 7.8 and 7.9 of the Table of Classifications and Standard Salary Rates under Managerial Category C, identified as Exhibit C to Ordinance No. O-16649 (New Series), dated May 27, 1986, be and the same is hereby adopted.

Section 4. That the Civil Service Commission and Personnel Department are directed to study and report upon, prior to and in time for consideration by the City Council of the fiscal year 1988 salary ordinance, the matter of reinstating the Principal Planner classification into the Classified service, to be effective July 1, 1987, providing therewith rationale and justification for consideration by the Council of such status change.

Section 5. This ordinance shall take effect and be in force immediately upon its adoption after two (2) public hearings,

pursuant to the authority contained in Sections 16, 17 and 71 of the Charter of The City of San Diego.

AN ORDINANCE NUMBER O-16719 (NEW SERIES AN ORDINANCE AMENDING ORDINANCE NO. 0-18678 (NEW SERIES), AS AMENDED, ENTITLED "AN ORDINANCE ADOPTING THE ANNUAL BUDGET FOR THE FISCAL YEAR 1868-87 AND APPROPRIATING THE NECESSARY MONEY TO OPERATE THE CITY OF SAN DIEGO FOR SAID FISCAL YEAR BY AMENDING DOCUMENT NO. 00-18676-1 AND 00-18678-2; AS AMENDED AND ADOPTED THEREIN, BY AMENDING THE PERSONNEL AUTHORIZATION OF THE PLANNING DEPARTMENT (065), IN GENERAL FUND 100; BY ADDING THREE (3.00) PRINCIPAL PLANNER POSITIONS THERETO AND DELETING ONE (1) SENIOR PLANNER, ONE (1) ABSOCIATE PLANNER, AND ONE (1) COMMUNITY DEVELOPMENT-SPECIALIST IV; EXEMPTING SAID THREE (3.00) PRINCIPAL PLANNER POSITIONS FROM THE CLASSIFIED SERVICE; AND ESTABLISHING A SALARY RATE THEREFOR; AND CHANGING THE TITLES OF ONE EXISTING (1.00) PRINCIPAL PLANNER POSITION TO ASSISTANT TO THE PLANNING DIRECTOR, ONE (1.00) EXISTING ASSISTANT TO THE TONING ADMINISTRATOR TO DEPUTY DIRECTOR AND ONE (1.00) EXISTING ASSISTANT TO THE PLANNING DIRECTOR TO PRINCIPAL PLANNER.

This ordinance amends the annual budget by amending the per-sonnel authorization of the Planning Department to add three (3) new Principal Planner positions and exempt them from the Classified Service. It further deletes one (1) Senior Planner, one (1) Associate Planner, and one (1) Community Development Specialist iv positions and changes titles of existing positions as follows: one (1) Principal Planner to Assistant to the Planning Director; one (1) Assistant Zon-

ing Administrator to Deputy Director; and one (1) Assistant to the Planning Director to Principle Planner.
