AN ORDINANCE AMENDING CHAPTER VI, ARTICLE 7, DIVISION 40, OF THE SAN DIEGO MUNICIPAL CODE BY AMENDING SECTION 67.40.1 RELATING TO WATER IMPOUNDING SYSTEM.

BE IT ORDAINED, by the Council of The City of San Diego, as follows:

That Chapter VI, Article 7, Division 40, of the Section 1. San Diego Municipal Code be and the same is hereby amended by amending Section 67.40.1 to read as follows:

SEC. 67.40.1 WATER IMPOUNDING SYSTEM

Α. PURPOSE AND INTENT

It is the purpose and intent of the Council in enacting this section that all City divers/rangers be specifically authorized pursuant to the provisions of Section 836.5 of the Penal Code of the State of California, to make arrests without a warrant whenever any such diver/ranger has reasonable cause to believe that the person to be arrested has committed a misdemeanor in the diver's/ranger's presence which is a violation of a statute or ordinance which such diver/ranger has the duty to enforce.

ARRESTS AND CITATIONS

That divers/rangers of The City of San Diego, be, and they are hereby authorized, empowered and given the duty to enforce provisions of the San Diego Municipal Code and

misdemeanors designated in the State Codes; to make arrests without a warrant whenever any such diver/ranger has reasonable cause to believe that the person to be arrested has committed a misdemeanor in the diver's/ranger's presence; and while engaged in the performance of their duties, to arrest persons and issue citations for violations of said Codes under the provisions of Sections 836.5 and 853.6 of the Penal Code of the State of California when violations occur in City of San Diego Water Impounding areas.

Section 2. This ordinance shall take effect and be in force on the thirtieth day from and after its passage.
