## SEC. 103.1501 BOUNDARIES

The regulations which follow shall apply in the areas of the Mid-City Community Planning Area in the City of San Diego, California, designated on those certain Map Drawing Nos. C-706.1, C-706.2, C-712 and C-706.3, and described in the appended boundary description filed in the office of the City Clerk.

Section 2. This ordinance shall take effect and be in force on the thirtieth day from and after its passage.
