AN ORDINANCE AMENDING ORDINANCE NO. 0-16678 (NEW SERIES), AS AMENDED, ENTITLED "AN ORDINANCE ADOPTING THE ANNUAL BUDGET FOR THE FISCAL YEAR 1986-87 AND APPROPRIATING THE NECESSARY MONEY TO OPERATE THE CITY OF SAN DIEGO FOR SAID FISCAL YEAR" BY AMENDING DOCUMENTS NO. 00-16678-1 AND NO. 00-16678-2, AS AMENDED AND ADOPTED THEREIN, BY ADDING TO THE AUTHORIZATION OF THE ENVIRONMENTAL GROWTH FUND 10505, A NEW BRUSH MANAGEMENT PROGRAM (DEPARTMENT 9320/PROGRAM ELEMENT 93257); AUTHORIZING THE ADDITION OF .37 INTERMEDIATE TYPIST AND .75 GROUNDS MAINTENANCE MANAGER TO SAID NEW PROGRAM; AUTHORIZING THE AUDITOR AND COMPTROLLER TO TRANSFER THE SUM OF \$865,358 FROM THE GENERAL FUND 100 [FIRE DEPARTMENT (120), PROGRAM ELEMENT 12033] TO FUND 10505 [DEPARTMENT 9320/PROGRAM ELEMENT 93257] FOR THE PURPOSE OF DEFRAYING PERSONNEL AND NONPERSONNEL EXPENSES OF THE BRUSH MANAGEMENT PROGRAM.

WHEREAS, during the FY 1987 Budget Review process on June 19, 1986, the Committee of the Whole approved the expenditure of \$1.1 million to implement a City-wide brush management program, including \$902,646 for brush management on public property; and WHEREAS, these funds were included in the Fire Department

WHEREAS, it was subsequently determined that the most efficient method of implementing the program was to assign the task of brush abatement on public property to the Park and Recreation Department which has been performing related activities and has expertise on the subject, the entire matter having been discussed in City Manager's Report No. 86-368; and

budget; and

WHEREAS, the Fire Department will perform the initial inspection and will prioritize areas for abatement; and

WHEREAS, the abatement will be accomplished by contract to be administered by two positions for the balance of the year in the Park and Recreation Department; and

WHEREAS, programs of this type are operated in the Environmental Growth Fund which is administered by the Park and Recreation Department and this action will transfer the approved amount to the proper fund; NOW, THEREFORE,

BE IT ORDAINED, by the Council of The City of San Diego, as follows:

Section 1. That Ordinance No. O-16678 (New Series), as amended, entitled "AN ORDINANCE ADOPTING THE ANNUAL BUDGET FOR THE FISCAL YEAR 1986-87 AND APPROPRIATING THE NECESSARY MONEY TO OPERATE THE CITY OF SAN DIEGO FOR SAID FISCAL YEAR," be and the same is hereby amended by amending Documents No. OO-16678-1 and No. OO-16678-2, as amended and adopted therein, by creating within the Environmental Growth Fund 10505, a new Brush Management Program (Department 9320/Program Element 93257).

Section 2. That there be and is hereby added to the personnel authorization of said newly created program .37 Intermediate Typist and .75 Grounds Maintenance Manager positions.

Section 3. That the Auditor and Comptroller be and he is hereby authorized to transfer the sum of \$865,358 from the General Fund 100 [Fire Department (120), Program Element 12033] to the Environmental Growth Fund 10505 (Department 9320/Program

Element 93257), for the sole and exclusive purpose of funding personnel and nonpersonnel expenses of the newly created Brush Management Program.

Section 4. This ordinance shall take effect and be in force immediately upon its adoption after two (2) public hearings, pursuant to the authority contained in sections 16, 17 and 71 of the Charter of The City of San Diego.
