AN ORDINANCE AMENDING ORDINANCE NO. O-16525  
(NEW SERIES), ADOPTED OCTOBER 28, 1985,  
REGARDING THE GREATER GOLDEN HILL PRECISE PLAN  
TO EXTEND THE EFFECTIVE DATE ONE YEAR.

WHEREAS, on August 28, 1986, the Planning Commission approved and recommended to the City Council that Ordinance No. O-16525 (New Series), adopted October 28, 1985, concerning the Greater Golden Hill Precise Plan area, be extended one year; NOW, THEREFORE,

BE IT ORDAINED, by the Council of The City of San Diego, as follows:


Section 1. That Section 6. of Ordinance No. O-16525 (New Series), adopted October 28, 1985, which expires on November 27, 1986, be and the same is hereby amended for the purpose of extending the effective date for one year, to read as follows:

"Section 6. This ordinance shall take effect and be in force 30 days from its adoption by the Council of The City of San Diego and shall remain in effect until November 26, 1987, or until the update of the Greater Golden Hill Precise Plan is completed, whichever comes first; unless it is extended by act of this Council or is superseded by new legislation."

Section 2. This ordinance shall take effect and be in force on the thirtieth day from and after its passage.


